



MFT Model Law

- Regulated by the title "marriage and family therapy and the practitioner as a "marriage and family therapist"
- Graduate training from a COAMFTE Accredited Program or equivalent
- 2 years post degree work experience
- Qualified supervision by an AAMFT Approved Supervisor
- Passes an examination




MFT Scope of Practice

The diagnosis and treatment of mental and emotional disorders, whether affective, behavioral, or cognitive, within the context of family systems.


Clinically Trained MH Clinicians in the U.S. 1991-2004




Changes in Primary Professions Identifying as MFTs



Growth of MFTs by Year




Practice Settings of MFTs In U.S.
